Manager's report

We have had good growth this financial year with total business as at 30th April 2009 of \$129 million which is growth for the 10 months of \$30 million. Portarlington has increased by \$10 million and Drysdale by \$20 million. It is great to see the support at Drysdale since it became a full **Community Bank**® branch in January. Between the two branches we now have over 7,000 accounts.

Whilst business growth has been very good this has not translated into revenue and increased profits which is disappointing given the efforts of all to grow the business. The reduced revenue is due to interest rates during the year as a result of the global economic conditions.

With the majority of our growth in deposits and in particular term deposits this has increased our cost of funding and reduced our margins. However, in the last two months we have seen our income increase as margins have improved and we expect this trend to continue in the short term with the Reserve Bank now having left interest rates unchanged in April and May.

Our new staff members have settled in well at both branches and are getting to know our customers. Our Customer Relationship

Officers, Kerry at Drysdale and Sheena at Portarlington, are able to open new accounts, term deposits, arrange personal loans and credit cards and assist with other enquiries away from the counter. This ensures that our customers receive efficient service.

We have again sponsored the National Celtic Festival held over the long weekend in Portarlington. This was the seventh year the festival has been held in Portarlington and it goes from strength to strength with visitors from around the world. For the first time tickets have been purchased by people in France. The event helps promote Portarlington and gives the local businesses a boost during what would be a quiet time in winter.

One of our community grants last year was \$10,000 to the Clifton Springs Pre-school for a new playground. The pre-school was also able to obtain some funding from the City of Greater Geelong to assist with the project. The playground has now been completed with the official opening held recently.

We thank the community for their continued support that enables us to contribute to the various events and projects in the area.

Youth Foundation

The Youth Foundations Victoria North Bellarine site will be holding their inaugural grants presentation evening at the end of June. The group (a Board comprised of local young people) has named themselves M.I.S.S.I.O.N. which stands for Many Individuals Supporting Socially Important Options on the North Bellarine.

Their aim is to make a positive change for disadvantaged young people on the North Bellarine. The grants are decided upon by M.I.S.S.I.O.N. and priority is given to projects that involve local North Bellarine communities and activities that involve young people.

The funding priorities set by M.I.S.S.I.O.N. for this grant round were: transport, entertainment and social connectedness, sport and recreation. Applicants were also required to address a charitable purpose.

State Conference

During April this year, our Board Support Officer Robyn Durran, Drysdale Manager Craig Taylor, fellow Director Sandra Baldwin and I attended the State Conference held by Bendigo and Adelaide Bank for the express benefit of **Community Bank®** branch staff and Directors.

These conferences are a chance for Directors to learn about what is happening in **Community Bank®** branches across the region (our region takes in NT, Tas, SA and Victoria). It is also a chance to showcase how branches are benefiting their communities and for Directors to get ideas and inspiration of how we could do similar things in our community.

Directors can often learn just as much by talking to fellow Directors at morning and afternoon tea as they do throughout the day!

I look forward to the opportunity to attend these events so I can continue to gather information and ideas to enable the Board of Directors to give our community the best possible outcomes.
