Trading your shares

All shares held and traded are registered with the Bendigo Stock Exchange (BSX) and are available for scrutiny on the BSX (www.bsx.com.au) website. Once logged on to the BSX website, go to 'MVF', the identifier code for Meander Valley Financial Services Ltd. To date, no shares have been traded. Should you wish to trade your shares - to buy or sell - unless you are an experienced share trader, you should seek the advice of your broker or financial advisor.

Share trades are subject to approval of the Board of Directors. The reason for this is to maintain some control of share distribution to ensure that shares are not traded outside the
