On the 10th of September, members of the MVFS Board attended the opening of the new **Community Bank®** branch in Bicheno. Its sister bank at Swansea opened several months ago and this new opening completed the first part of that community's strategy to return banking to the communities on the East Coast. Our branch staff, led by Darren Rumble, our new Manager, supported by Kelly Hills, the new supervisor, and branch staff, Kellie Challis, Susan Drake, Kim Walters and Kim Hanson, and the MVFS Board members who work very hard as volunteer Directors.





Bendigo Bank response to the sub-prime market

In view of the current global credit market breakdown, the following statement was circulated to all Bendigo Bank and **Community Bank®** branches for the information of customers.

"Bendigo Bank holds very few direct equity investments. Those we do hold are in financial services and related companies (e.g. IOOF, Australian Wealth Management), or community oriented companies (e.g. Community Telco Australia). We have no holdings in industrial stocks and therefore have no investments in companies that cause environmental degradation (e.g. wood-chipping) or potentially infringe human rights (e.g. armaments)."

"Bendigo Bank's core business is raising deposits which we then lend out to people to buy homes, run small to medium businesses and farms, or make purchases (Credit cards). Our credit policy includes safeguards to ensure we do not lend for illegal or environmentally harmful purposes."
