# Report from the Treasurer

Since the last time I wrote a report to shareholders the financial strength of our Company has considerably improved. Business on the books of our Bank has grown from \$40 million to over \$72 million at the time of writing this report.

For the financial year ended 30 June 2008 the Company made its first profit being \$26,862 after provision for Income Tax. For the half year ended 31 December 2008 an after tax profit of \$32,837 has been made. Despite the world financial downturn the business is still expected to grow and the profit forecast for the financial year ended 30 June 2009 should be met.

As stated by the Chairman in the last Annual General Meeting on 15 November 2008 the Company is on track to declare its first dividend to shareholders for the year ended 30 June 2009. So that we can continue to progress towards this goal and achieve our other major goal of distributing actual profits to the community by way of community grants, the business needs your full support.

You have no doubt seen publicity about sponsorships and gifts that the Company has made to date. Such amounts are from a "Market Development Fund" provided by our partner Bendigo and Adelaide Bank for business promotion purposes. This also includes costs associated with advertising and business promotion in general. The larger benefits to the Community will come when adequate available profits can be released by way of Community Grants

I know that Sarina and District can benefit from this **Community Bank®** business. It has happened elsewhere in Australia many times with outstanding results for the local communities involved. Neither I, nor my fellow Directors would put so much voluntary time and effort into the business if this were not the case. How quickly the community benefits from the business, is in the control of the local community.
