Grantville are steadily raising their pledged amount and are currently sitting on \$121,500. This is a great effort from a very hard working and industrious group.

The spread of **Community Bank®** branches through the Bass Coast Shire is and will be an ideal method of keeping money spent locally within the area.

At the moment we have our Company (San Remo District Financial Services) being valued to incorporate the influx of new shareholders (Cowes) into the spread, this will mean our present shareholders can expect a bonus issue of shares.
